CASE MANAGEMENT ORDER NO. 48

This Matter having come before the Court for a Case Management Conference; counsel having reported to the Court the status of the litigation,

IT IS on this 23rd day of June, 2015;

ORDERED as follows:

1. Defendants' Report
 - a. There are 17 Plaintiffs who were required to come up with prescription, fill of prescription, and event records and failed to comply. These cases will be dismissed pursuant to the 5-day rule.
 - b. There are 3 Plaintiffs who failed to supply a PFS.
 - i. One will be dismissed without prejudice pursuant to the 5-day rule: *Melissa Oatley v. Bayer Corp., et al.* (Docket No. BER-L-8149-14).
 - ii. The other two are given 45 days to supply a PFS; the Complaints will be dismissed without prejudice if there is no compliance. These two cases are:
 1. *Parker v. Bayer Corp., et al.* (Docket No. BER-L-3430-11)
 2. *Farrell v. Bayer Corp., et al.* (Docket No. BER-L-635-14).

- c. There are 191 cases remaining: 83 VTE cases, 29 arterial cases, 39 other cases, and 1 unknown case.
 - i. For the VTE cases, the parties shall continue to meet and confer to attempt to resolve these cases.
 - ii. For the 39 other cases, counsel shall meet and confer and provide the Court with a specific docket report for each member of this group. At the next conference, counsel shall discuss the status of these cases and develop a plan moving forward.
2. The Discovery End Date in this matter is now December 31, 2015.
3. The next case management conference is scheduled for September 15, 2015 at 11:00am.
