
THIS MATTER having come before this Court upon the filing of three motions, having considered the moving papers filed herein, and having conducted a Case Management Conference, the MCL component of the matter having been concluded, the Court hereby entered the following order.

IT IS on this 18th day of December 2014 Ordered:

1. During the Case Management Conference, counsel met and conferred and agreed on the following dates:
 - a. January 7, 2015: Deposition of Dr. Howard Benn. The parties agreed on a firm date, which is not to be adjourned absent consent of Plaintiff's Counsel and Dr. Benn's Counsel.
 - b. January 14, 2015: Deposition of Mr. Patel/Passaic Pharmacy. The parties agreed on a firm date, which is not to be adjourned absent consent of Plaintiff's Counsel and Mr. Patel/Passaic Pharmacy Counsel.
 - c. The deposition of Defendant Campbell and Corporate Designee of St. Mary's Hospital will occur on or before January 31, 2015.
 - d. Defendant St. Mary's Hospital will advise, by December 31, 2014, if "Sandy" is still a St. Mary's Hospital employee. If so, deposition will be completed by February 15, 2015. If not, St. Mary's Hospital will provide Sandy's last known address information, so the deposition can be completed by subpoena on or before February 15, 2015.
 - e. The depositions of any other fact witnesses will be completed by March 1, 2015.
 - f. Plaintiff expert reports will be submitted by April 15, 2015.
 - g. Defense expert reports will be submitted by June 15, 2015.
 - h. Expert depositions will be completed by August 31, 2015.
 - i. The new discovery end date is September 15, 2015.
2. The case type on this matter is changed from a Yaz/Yasmin/Ocella MCL (287) to a Medical Malpractice (604); the Track Assignment will also change to reflect a Track 3 designation, and the matter will be assigned to the Honorable Charles E. Powers, J.S.C.

3. The parties shall contact the Honorable Charles E. Powers, J.S.C. for a Case Management Conference at the conclusion of fact discovery to address any outstanding discovery issues.
