

**MEMORANDUM DECISION**

**MARTINOTTI, J.S.C.**

Before this Court were ninety-eight (98) motions<sup>1</sup> to dismiss filed by Defendants Bayer (sixty-six (66) were returnable on October 11, 2013, one (1) was withdrawn and the remaining were unopposed; twenty-three (23) were returnable on October 25, 2013, with one (1) being withdrawn and three (3) being opposed<sup>2</sup>; one (1) returnable on November 8, 2013, one (1) returnable on November 22, 2013, two (2) returnable on December 6, 2013, two (2) returnable January 17, 2014, two (2) returnable January 31, 2014, and one (1) returnable February 28, 2014). The present motion is petitioning this Court, pursuant to Case Management Order No. 39, Section II, to dismiss Plaintiff's Complaint With Prejudice for failure to produce expert reports on general and specific causation. See Case Management Order No. 39.

The YAZ®, Yasmin®, Ocella® Litigation was designated a Multi-County Litigation (MCL) by order of the Supreme Court on February 9, 2010. The cases were assigned to Bergen County on February 18, 2010. Since the MCL, forty-five (45) Case Management Orders have

been entered. This Court has coordinated its efforts with the pending Multi-District Litigation (MDL), presided over by the Honorable David R. Herndon, Chief Judge, USDJ.

On March 15, 2013, this Court entered Case Management Order No. 39. Section II Paragraph A requires Plaintiff's to produce certain discovery, including expert reports on general causation and a case-specific expert report regarding the cause of the gallbladder injury. Section II also requires Plaintiff's to produce a Plaintiff Fact Sheet and authorizations pursuant to CMO 7, all pharmacy and medical records from 3 years prior to the diagnosis of the gallbladder injury to the present, and a certification that the pharmacy and medical records have been collected and produced to Defendants.

As to the aforementioned discovery, for cases filed before March 26, 2013, they were due to Defendants by July 22, 2013. If a Plaintiff failed to comply with the discovery requirements as articulated in CMO 39, Defendant must notify Plaintiff in writing of said failure, after which Plaintiff has 30 days to cure the deficiencies. After such time has lapsed, if Plaintiff has not cured, Defendant may move the Court for an Order dismissing the Complaint with Prejudice. Plaintiff has 30 days afterward to respond.

On August 26, 2013, Plaintiff Victoria Redman's now former Counsel, Lopez McHugh LLP, filed a motion to withdraw as Plaintiff's Counsel. Pursuant to the Court's Order, all notices were sent directly to Plaintiff Redman's home address. On December 6, 2013, Defense Counsel notified Plaintiff Redman that if the delinquent discovery was not received by January 5, 2014, Defendants would move for dismissal of her case. To date, Plaintiff has failed to respond.

The Plaintiff has not complied with the deadlines established in Case Management Order No. 39. Specifically, she has failed to provide the required expert reports. This Court finds that

Plaintiff has not complied with this Court's order and therefore, the Defendant's motion to Dismiss Victoria Redman's Complaint with Prejudice is GRANTED.

Bayer has moved to dismiss this action for failure to serve preservation notices required by Case Management Order No. 39 ("CMO 39").

Plaintiff filed her complaint on October 21, 2009. She alleged a gallbladder injury as a result of her ingestion of YAZ and Yasmin. Pursuant to Section II of CMO 39, Ms. Redman was required to produce certain discovery materials by July 22, 2013. These included expert reports on general and specific causation. Section II.E of CMO 39 provides as follows: "Plaintiffs who fail to fully comply with the requirements of this Order shall be given notice of such failure by e-mail or fax from Defendants' Liaison Counsel or his/her designee and shall be provided thirty (30) additional days to cure such deficiency ("Cure Period"). No other extensions will be granted. If Plaintiff fails to cure the deficiency within the Cure Period, Defendant's Liaison Counsel or his/her designee shall file a Motion to Dismiss the Gallbladder Claim with prejudice. Plaintiff shall thereupon have thirty (30) days to respond to the Motion to Dismiss. Any failure to respond to the Motion to Dismiss within the required period of time shall lead to the dismissal of the Gallbladder Claim with prejudice, except for good cause shown."

I have examined the motion papers submitted by Bayer. It appears that Bayer sent a letter by Federal Express to the Plaintiff on December 6, 2013 pointing out the failure to comply with CMO 39 and warning her that Bayer would move to dismiss if there was no compliance by January 5, 2014.<sup>1</sup> Bayer thereafter filed its motion to dismiss on January 7, 2014. Plaintiff has had 30 days to respond and has filed no response.

The Court appointed me Special Master in Section III of CMO 39 to make recommendations on motions. I have considered the provisions of CMO 39 and the material submitted by Bayer in support of its motion.

Since Ms. Redman has not complied with Section I.D. of CMO 39 and has not cured her failure to comply, I recommend that the Court grant Bayer's motion to dismiss.
