

Douglas, Esq. shall be and is admitted to practice *Pro Hac Vice* before this Court pursuant to *R. 1:21-2*, for all purposes and in all proceedings in which he or his firm, Douglas & London, P.C., have filed and served action, in the same manner as an attorney who is admitted to practice in this State and is domiciled and maintains an office for the practice of law in the State of New Jersey;
2. Gary J. Douglas, Esq. shall abide by the Rules of Court for the State of New Jersey, including all disciplinary rules, R 1:20-1 and R 1:28-2;
3. Gary J. Douglas, Esq. shall consent to the appointment of the Clerk of the Supreme Court as an agent upon whom service of process may be made for all actions against him and his firm that may arise out of his participation in this matter;
4. Gary J. Douglas, Esq. shall notify the Court immediately of any matter effecting his standing before this Court;
5. Gary J. Douglas, Esq. shall have all pleadings, briefs and other papers filed with the Court signed by an attorney-at-law of this Court employed by Douglas & London, P.C., authorized to practice in this State, who shall be responsible for the conduct of Gary J. Douglas, Esq., and it is;
