is domiciled and maintains an office for the practice of law in the State of New Jersey provided that she shall:


1. Abide by the Rules of the Court for the State of New Jersey, including R.1:21-7, and including all disciplinary rules; and

4. Have all pleadings, briefs and other papers filed in this Court signed by an attorney-at-law of this Court employed by the law firm of Levin Fishbein Sedran & Berman, who shall be responsible for them, for the conduct of the cause of Wendy R. Fleishman, Esquire.
