**WHEREAS**, Plaintiff, by and through her attorneys, Williams Cuker Berezofsky, upon notice to all interested parties, have moved before this Court for admission *Pro Hac Vice* of Wendy R. Fleishman, Esquire, and the Court having found that Wendy R. Fleishman, Esquire, is a member in good standing before the bar of the highest court of the state where she is domiciled and principally practices law, and for other good cause shown,

**IT IS** on this 6 day of August, 2010,

**ORDERED** that the Motion is granted, and Wendy R. Fleishman, Esquire, is admitted to practice *pro hac vice* before this Court, pursuant to R.1:21-2, for all purposes and in all proceedings connected with the above-referenced matter, in the same manner as an attorney who is admitted to practice in this State and is domiciled and maintains an office for the practice of law in the State of New Jersey provided that she shall:

1. Abide by the Rules of the Court for the State of New Jersey, including R. 1:21-7,

and including all disciplinary rules; and

2. Consent to the appointment of the Clerk of the Supreme Court as her agent upon whom service of process may be made for all actions against her or her respective firm that may arise out of their participation in the matter; and,

3. Notify the Court immediately of any matter affecting her standing at the bar of any Court; and,


4. Have all pleadings, briefs and other papers filed in this Court signed by an attorney-at-law of this Court employed by the law firm of Williams Cuker Berezofsky, who shall be responsible for them, for the conduct of the cause and of Wendy R. Fleishman, Esquire.

**IT IS FURTHER ORDERED THAT** a copy of this Order shall be served on all parties within seven (7) days of the date hereof.
