ORDER TO ADMIT ERIC ANIELAK, ESQ.
PRO HAC VICE

THIS MATTER being opened to the Court by Susan M. Sharko, Esq., a New Jersey attorney and one of the attorneys of record for defendants Bayer Pharma AG, Bayer Corporation, Bayer HealthCare, L.L.C. and Bayer HealthCare Pharmaceuticals Inc., to permit Eric Anielak, Esq., an attorney admitted to the practice of law in the State of Missouri, to participate with

other counsel for defendants Bayer Pharma AG, Bayer Corporation, Bayer HealthCare, L.L.C. and Bayer HealthCare Pharmaceuticals Inc. in all phases of the trial, and it appearing that Eric Anielak, Esq. is a licensed attorney in good standing in the State of Missouri, and it appearing that plaintiff's complaint raises products liability claims, and it further appearing that the law practice of Eric Anielak, Esq. focuses on the trial and appeal of products liability cases, and it further appearing that defendants Bayer Pharma AG, Bayer Corporation, Bayer HealthCare, L.L.C. and Bayer HealthCare Pharmaceuticals Inc. have requested that Eric Anielak, Esq. represent them in this matter, and the court having considered the respective certifications of Jennifer LaMont, Esq. and Eric Anielak, Esq., submitted in support of the motion, and for good cause having been shown:

IT IS this FIRST day of NOVEMBER, 2011 ORDERED that Eric Anielak, Esq. shall be and hereby is admitted *pro hac vice* and is authorized to appear and participate with other counsel for defendants Bayer Pharma AG, Bayer Corporation, Bayer HealthCare, L.L.C. and Bayer HealthCare Pharmaceuticals Inc. in all phases of the trial, subject to the following conditions:

1. Eric Anielak, Esq. shall abide by the New Jersey Court Rules including all disciplinary rules, R. 1:20-1 and R. 1:28-2.
2. Eric Anielak, Esq. shall, and hereby does, consent to the appointment of the Clerk of the Supreme Court as agent upon whom service of process may be made for all actions against him or Shook, Hardy & Bacon, L.L.P. that may arise out of his participation in this matter.
3. Eric Anielak, Esq. shall immediately notify the Court of any matter affecting his standing at the Bar of any other Jurisdiction.

4. Eric Anielak, Esq. shall have all pleadings, briefs and other papers filed with the court signed by an attorney of record authorized to practice in New Jersey, who shall be held responsible for them, the conduct of the litigation and the attorney admitted herein.

5. Eric Anielak, Esq. cannot be designated as trial counsel.


6. No discovery, motion, trial or any other proceeding delay shall occur or be requested by reason of the inability of Eric Anielak, Esq. to be in attendance.

7. Eric Anielak, Esq. must, within ten (10) days of receipt of this Order, pay the fees required by R. 1:20-1(b) and R. 1:28-2 and submit an affidavit of compliance.

8. The *pro hac vice* admission of Eric Anielak, Esq. will automatically terminate for failure to make the initial and any annual payment required by R. 1:20-1(b) and R. 1:28-2.

9. Non-compliance with any of the terms of this Order shall constitute grounds for removal.

10. A true copy of this Order shall be served upon all counsel of record within seven (7) days of the date hereof.
