1. Michelle R. Mangrum, Esq. shall abide by the New Jersey Court Rules including all disciplinary rules, R. 1:20-1 and R. 1:28-2.
2. Michelle R. Mangrum, Esq. shall, and hereby does, consent to the appointment of the Clerk of the Supreme Court as agent upon whom service of process may be made for all actions against her or Shook, Hardy and Bacon, LLP that may arise out of his participation in this matter.
3. Michelle R. Mangrum, Esq. shall immediately notify the Court of any matter affecting her standing at the Bar of any other Jurisdiction.

4. Michelle R. Mangrum, Esq. shall have all pleadings, briefs and other papers filed with the court signed by an attorney of record authorized to practice in New Jersey, who shall be held responsible for them, the conduct of the litigation and the attorney admitted herein.

5. Michelle R. Mangrum, Esq. cannot be designated as trial counsel.



8. The *pro hac vice* admission of Michelle R. Mangrum, Esq. will automatically terminate for failure to make the initial and any annual payment required by R. 1:20-1(b) and R. 1:28-2.

9. Non-compliance with any of the terms of this Order shall constitute grounds for removal.

10. A true copy of this Order shall be served upon all counsel of record within seven (7) days of the date hereof.
