### 1. CASE LIST:

 Counsel for Plaintiffs, Marc J. Bern & Partners LLP must resubmit its case list in the following format for administrative purposes: Docket Number, Caption, and Date of Filing.

## 2. COMPLAINTS

- All complaints filed in this MCL shall include a single plaintiff.
- For all complaints currently filed with the court that contain multiple plaintiffs, Plaintiffs'
   counsel shall file two motions to correct those pleadings
  - o First, Plaintiffs' counsel shall file a motion to amend the caption to remove all of the plaintiffs except the first identified plaintiff in the case caption. The first identified plaintiff in the case caption of a multiple plaintiff complaint will remain assigned to that original docket number and case caption.

- Second, Plaintiffs' counsel shall file a motion to bifurcate the claims of each plaintiff, except the plaintiff identified first in the case caption. Each plaintiff shall file a separate complaint which will be assigned its own independent docket number once the motion to bifurcate is granted.
- The bifurcated and amended complaints shall retain their original filing and dates.

  The motions to amend and to bifurcate the claims of individual plaintiffs in complaints naming multiple plaintiffs shall be filed by December 28, 2018.
- Defense counsel shall file responsive pleadings in response to motions to amend the
  caption and new original responsive pleadings to the bifurcated complaints once the
  motions are granted pursuant to the deadlines set by the court's order. The amended
  answers or responsive pleadings shall retain their original filing dates.

#### 3. ANSWERS

- Going forward, All Answers must name a single Plaintiff and will be applicable to only to the Plaintiff named.
- Answers already filed which are deficient as a result of naming multiple
   Plaintiffs shall not be filed. Counsel for Defendants may resubmit individual
   Answers to each Plaintiff's Complaint.

- All pleadings should contain original signatures.
- All submissions to the court must be single sided.

- Certifications of Compliance shall only be one page in length.
