CASE MANAGEMENT ORDER #11 OCTOBER 27, 2020 CASE MANAGEMENT CONFERENCE

THIS MATTER, having come before the Court at a case management conference on October 27, 2020 and counsel for Plaintiffs and counsel for Defendants having been present, and for good cause having been shown;

IT IS on this 18th day of November 2020, **ORDERED** as follows:

1. DECEASED PLAINTIFFS

- As set forth in CMO #10, Plaintiffs' counsel shall not file complaints on behalf of a
 deceased Plaintiff unless filed through an estate representative.
- The following cases identified in Exhibit A are hereby dismissed with prejudice since the complaint was filed after the Plaintiff was deceased and therefore the deceased Plaintiff did not have standing to file the complaint.
- If Plaintiffs' counsel has proof that the Plaintiff was not deceased at the time the complaint was filed, they may file a motion for reconsideration of the dismissal on that basis only.
- Plaintiff's counsel may seek to file a new complaint through an estate representative.

2. COMPLAINTS ASSERTING A CLAIM FOR LOSS OF CONSORTIUM WITHOUT AN IDENTIFIED SPOUSE.

 Plaintiffs' counsel shall file corrected Amended Complaints by November 30, 2020 for those cases identified in Exhibit B.

- The corrected Amended Complaint shall identify a spouse if a Loss of Consortium claim is asserted and shall identify the spouse as a party in the caption of the Amended Complaint.
- The Amended Complaint shall be served upon Defendants as follows:
 - On Merck as follows:
 - For amended complaints in cases previously served on Merck: via email at ZostavaxMCL_Complaints@venable.com.
 - For amended complaint in cases where Merck was not previously served,
 such amended complaints shall be formally served on Merck.
 - On McKesson as follows:
 - For amended complaints in cases previously served on McKesson, on McKesson's defense counsel in Zip files via email at wfrisch@clarkhill.com and jsaruya@clarkhill.com.
 - For amended complaints in cases where McKesson was not previously served, such amended complaints shall be formally served on McKesson. This includes, but is not limited to, the cases identified in Exhibit A to the Court's August 27, 2020, Order Regarding Service of Amended Short Form Complaints for Previously Filed Single Plaintiff Complaints.

3. BELLWETHER CASE SELECTIONS

- Defense counsel shall have a meet and confer with representatives of Bern LLP and Sadaka law offices on December 11, 2020 regarding a future bellwether pool to include non-shingles cases.
- Plaintiffs shall identify their 15 bellwether case selections by November 12, 2020.
 Defendants shall select 7 bellwether case selections by November 12, 2020, and their remaining 8 by December 9, 2020. All other deadlines of the August 27, 2020 Amended Bellwether Order remain as scheduled.

4. **DEPOSITION PROTOCOL**

• Counsel shall meet and confer regarding a deposition protocol by November 30, 2020.

5. CERTIFICATIONS OF COUNSEL REGARDING PLAINTIFF CERTIFICATION ALTERATIONS.

By November 20, 2020, Plaintiffs' counsel shall propose a certification to Defense
Counsel which specifically identifies and delineates counsel's authority to change the
date of a Plaintiff's certification of the Plaintiff Fact Sheet. The certification of counsel
shall specifically confirm that Plaintiff has reviewed and certified the document contents
and has authorized counsel to update or change the date of a previously submitted
certification.

6. UPDATED CASE LIST

- By November 27, 2020, Marc J. Bern of Bern LLP shall submit his case list to the Court
 via email to Marisol Rodriguez at Marisol.Rodriguez@njcourts.gov, or he may be called
 upon by the Court on an Order to Show Cause why he should not be held in contempt for
 failure to comply with this Order.
- By November 27, 2020, the Law Offices of Mark Sadaka shall, to the extent applicable, submit a list of new cases filed after 9/18/2020 to the Court via email to Marisol Rodriguez at Marisol.Rodriguez@njcourts.gov
