CASE MANAGEMENT ORDER #17 JUNE 2, 2021 CASE MANAGEMENT CONFERENCE

IN RE: ZOSTAVAX® LITIGATION

THIS MATTER, having come before the Court at a case management conference on June 2, 2021 and counsel for Plaintiffs and counsel for Defendants having been present, and for good cause having been shown;

IT IS on this 13th day of July, hereby **ORDERED** as follows:

1. MOTIONS TO COMPEL ANSWERS TO PLAINTIFF FACT SHEET (PFS) DEFICIENCIES

- Counsel for Merck will provide plaintiffs' counsel with a list of cases for which they have served a PFS deficiency letter and not received a response.
- Counsel for plaintiffs shall provide the court with a delineation of motions that will not be opposed, will be opposed and the reason for the opposition by June 16, 2021.
- Counsel for Merck may file an omnibus motion to compel responses to PFS deficiencies in the master docket.
- Counsel for plaintiffs will file any opposition to the omnibus motion in the individual docket for the cases opposed.
- Following the court's decision, counsel for Merck shall draft separate orders
 memorializing the decision for each case to be loaded into the individual e-court docket
 of each case.

2. CONVERTING DISMISSALS WITHOUT PREJUDICE TO DISMISSALS WITH PREJUDICE.

- Merck may seek dismissal of a case with prejudice if plaintiffs' counsel has not moved to reinstate a case dismissed without prejudice within 60 days from the date of the dismissal.
- For cases dismissed under Order 10 (February 13, 2020) Merck shall submit proposed orders to the Court seeking conversion from dismissal without prejudice to dismissal with prejudice with 10 days' notice to provide plaintiffs' counsel the opportunity to submit opposition to the form or substance of the proposed dismissal order.
- If opposition is not received within 10 days, the Court will execute Merck's proposed order.

3. AMENDED SHORT FORM COMPLAINTS TO CORRECT LOSS OF CONSORTIUM ALLEGATION ERRORS
