THIS MATTER, having come before the Court at a case management conference on July 15, 2021 and counsel for plaintiffs and counsel for defendants having been present, and for good cause having been shown;

IT IS on this 29th day of July, ORDERED as follows:

1. PENDING MOTIONS UPDATE CHART

• Defense liaison counsel and plaintiffs' liaison counsel shall provide quarterly lists to the court setting forth the pending motions for their respective clients. Plaintiffs' list shall include the pending motions from all plaintiffs' counsel and the defense list shall include pending motions for both Merck and McKesson. The next list shall be provided with the October Case Management Conference agenda.

2. MOTIONS TO AMEND TO SUBSTITUTE THE ESTATE

- Plaintiffs' counsel shall provide a list to the court and opposing counsel by August 24, 2021, which sets forth the following:
 - The name and docket number for all cases for which the plaintiff is deceased, and the complaint needs to be amended to substitute the estate for the deceased plaintiff.
 - The information plaintiff's counsel has in their possession to support the motion to amend to substitute the estate ("motion to amend").

The posting of this Order on eCourts shall constitute service upon all counsel of record. If applicable, pursuant to *Rule* 1:5-1(a), the movant shall serve a copy of this Order upon all parties not served electronically within seven (7) days of receipt of this Order.

The Court is in receipt of Plaintiff's counsel's objection to paragraph 4 of this Order, sent via email. Specifically, the issue involves lead Plaintiffs who had been dismissed, and thereafter reinstated via stipulation, for a limited purpose which has now occurred. There is no dispute that

these Plaintiffs need to again be dismissed with prejudice, however, Plaintiff's counsel requests that for its internal reasons, these Plaintiffs be dismissed with prejudice via Court Order, in lieu of stipulation of dismissal. Defense counsel requests that they be dismissed via stipulation. The Court records disclose that these Plaintiffs had originally signed and submitted stipulations of dismissal to the Court. However, because these were lead Plaintiffs, these stipulations were not entered, but rather were held in abeyance for purposes of bifurcation. While these Plaintiffs were, however included in the Court's February 13, 2020 Order, consistent with the procedures outlined above, new stipulations of dismissal need to be filed. In light of the delays to date, these stipulations are to signed and return to defense counsel by August 2, 2021, to be filed with the Court by August 9, 2021.
