THIS MATTER, having come before the Court at a case management conference on August 6, 2019 and counsel for Plaintiffs and counsel for Defendants having been present, and for good cause having been shown

IT IS on this 23 day of August 2019, ORDERED as follows:

**1. COURT SUBMISSIONS**

- d) A return envelope with prepaid postage must accompany all filed Complaints, or a filed stamped copy will not be provided to counsel.

## **2. MASTER PLEADINGS**

- Defendants' Motions for Reconsideration of the Court's decision regarding the Motions to Dismiss portions of Plaintiffs' Long Form Complaint is returnable August 30, 2019.
- Plaintiffs' Opposition is due on August 15, 2019.
- Defendants' reply briefs are due August 23, 2019.
- Oral argument will be held on September 6, 2019, at 10:30 AM in courtroom 403.
- The Court's decision will be placed on the record on September 9, 2019.

## **3. STAY OF DEADLINE TO FILE ANSWERS**

- Defendants' deadline to file Answers or otherwise respond to all complaints remain stayed pending determination of Defendants' motion for reconsideration and anticipated motions to dismiss counts of the Amended Master Complaint and until further order of the Court.
- Plaintiffs' motion to Amend the Long Form Complaint is due October 9, 2019 or within 30 days of the Court's Order concerning Defendants' motion for reconsideration of portions of Plaintiffs' Long Form Complaint, whichever is later.
- Defendants' motion to dismiss the Amended Long Form Complaint is due October 30, 2019 and will be returnable November 20, 2019.
- Plaintiff's opposition is due November 8, 2019 and Defendants' reply brief is due November 14, 2019.
- A decision will be placed on the record on November 22, 2019.

- Defense and Plaintiffs' counsel will meet and confer with plaintiffs' liaison counsel regarding a rolling procedure to respond to the complaints and a rolling procedure to submit motions to bifurcate multi-plaintiff complaints and have proposal(s) to present during October 10, 2019 Case management Conference. A future order will address the deadlines for plaintiffs' motions to bifurcate the multi-plaintiff complaints, filing of the bifurcated complaints and defendants' answers.

**4. BELLWETHER ORDER**

The parties will discuss the status of the Bellwether Order at the Case Management Conference scheduled for October 10, 2019, including whether and when non-shingles injury cases should be worked up.
