STATEMENT OF REASONS

This Matter comes before the Court upon Defendants' Motion to Dismiss Plaintiff's Complaint with prejudice pursuant to R. 4:23-2 for Plaintiff's failure to provide Proof of Use. The Court, having considered the moving papers submitted, and having found this Motion unopposed, will be granting same essentially for the reasons set forth in the moving papers in accordance with R. 1:6-2. The Court notes the following additional procedural history: Plaintiff's case was dismissed without prejudice via Order on August 3, 2021, for failure to provide Proof of Use. Additionally, Plaintiff's case was dismissed without prejudice via an Order for failure to provide a completed Plaintiff Fact Sheet on August 6, 2021. Accordingly, at this time, more than sixty (60) days have passed since Plaintiff's case was dismissed without prejudice, Plaintiff has not filed a Motion to Reinstate, nor filed an opposition. A dismissal with prejudice is now warranted in accordance with R. 4:23-5(a)(2). Thus, this Motion is **GRANTED**, and Plaintiff's case is **DISMISSED WITH PREJUDICE**.
