CONSENT ORDER

- The cases set forth in Exhibit A shall be dismissed without prejudice if they fail to provide Proof of Use with page and line reference within 45 days of the date of this Order.
- 2. Within 45 days of this Order, plaintiffs' counsel shall identify to counsel for Merck those cases from Exhibit A for which sufficient proof of use with page and line reference has been served pursuant to this Order.
- 3. Following the 45th day, Defense counsel may submit an Order for dismissal of the cases without prejudice that have failed to comply with this Order and not identified by plaintiffs' counsel as compliant.
- 4. Any dispute as to sufficiency of the proof of use after page and line reference is provided shall be resolved by the Judge upon motion and any such case will not be subject to this consent order.

ORDERED, that service of this Order shall be deemed effectuated upon all parties upon its upload to e-Courts. Pursuant to <u>Rule</u> 1:5-1(a), movant shall serve a copy of this Order on all parties not served electronically within seven (7) days of the date of this Order.
