AND NOW, this 30th day of November 2021, upon consent of all counsel of record in this matter; it is hereby **ORDERED** as follows:

- 1. The cases set forth in Exhibit A shall be dismissed without prejudice if they fail to provide proof of product usage within 45 days of the date of this Order.
- 2. Within 45 days of this Order, plaintiffs' counsel shall identify to counsel for Merck those cases from Exhibit A for which proof of product usage has been served pursuant to this Order.
- 3. Following the 45th day, Defense counsel may submit an Order for dismissal of the cases without prejudice that have failed to comply with this Order and not identified by plaintiffs' counsel as compliant.
