Statement of Reasons

This matter comes before the Court by way of Plaintiffs' Motion to Vacate dismissal of numerous Plaintiffs' Complaints. <u>See</u> Attached Schedule. These Complaints were dismissed by the Court on February 13, 2020 with prejudice for plaintiffs' counsel's failure to comply with numerous Court Orders and deadlines upon which plaintiffs' counsel were to provide defense counsel and the Court with sufficiently complete Plaintiff Fact Sheets ("PFS") and/or proof of Product Usage. After a lengthy meet and confer process and numerous conferences with the Court, defense counsel has advised the Court and plaintiffs' counsel that Defendants will not oppose vacating the dismissal of the Complaints in the dockets referenced in the Schedule attached to this Order.

While it is the Court's intent to **GRANT** Plaintiffs' Motions to Vacate, the Court notes that the Motions subject to this Order were filed under "master dockets". Pursuant to Case Management Order 8 and Order dated March 17, 2020, an individual Complaint must be filed for each Plaintiff. With the exception of the three (3) cases noted below, none of the Plaintiffs subject to this Order have individual Complaints filed.

Accordingly, to ensure compliance with this Court's previous Orders, plaintiffs' counsel may file individual Complaints, under individual docket numbers, for the Plaintiffs whom the Court is vacating dismissal for today within fourteen (14) days of the date hereof. See Schedule; plaintiffs' counsel must also serve same within fourteen (14) days of the date of this Order. The Plaintiffs subject to this Order may thereafter proceed with their cases utilizing their respective docket numbers and will be marked as "disposed" by the Court under the dockets referenced in the attached Schedule.

As it relates to Plaintiffs Gwendall Jenkins, Hazel Tommerline, and James Miller, (all referenced below) Plaintiffs' counsel filed Motions to Vacate under master dockets when these three (3) Plaintiffs have their own individual docket. Accordingly, the Court will be "disposing" of these Plaintiffs from the dockets in which these Motions were filed, and their cases may proceed under their individual dockets without further action from Plaintiffs' counsel.
