ORDER ADMITTING COLLEEN MILLER, ESQ., PRO HAC VICE

WHEREAS, Plaintiff, John Wesselink, by and through his attorneys Marc J. Bern & Partners LLP upon notice to all interested parties, has moved before this Court for admission *pro hac vice* of Colleen Miller, Esquire; and the Court having considered the papers submitted in support thereof; and the Court having found that Colleen Miller, Esquire, is a member in good standing before the bar of the highest Court of the State of New York, where she is domiciled and principally practices law; and for other good cause shown,

responsible for them, for the conduct of the cause of Colleen Miller, Esquire; and

5. that Colleen Miller, Esquire, not be designated as trial counsel and must be accompanied

by a member of the New Jersey bar for all proceedings, unless specifically waived by the

Court.

IT IS FURTHER ORDERED that Colleen Miller, Esquire, shall make payment of all fees due to the

State of New Jersey within 30 days of the entry of the pro hac vice Order allowing for admission and as

provided in the New Jersey Rules of Court, R. 1:20-l(b), 1:28-2, and R. 1:28B-l (e).

IT IS FURTHER ORDERED that pro hac vice admission in the State of New Jersey shall

automatically terminate for failure to make the initial payment required by \underline{R} . 1:20-1(b), \underline{R} . 1:28-1, and \underline{R} .

1:28-2.

IT IS FURTHER ORDERED that service of this Order shall be deemed effectuated upon all parties

upon its upload to e-Courts. Pursuant to R. 1:5-1(a), movant shall serve a copy of this Order on all parties not

served electronically within two (2) days of the date of this Order.
