September 15, 2010 adopting amendments to N.J.R.E. 804 of the New Jersey Rules of

Evidence. The amendment adopts a forfeiture-by-wrongdoing exception to the hearsay

rule (N.J.R.E. 804(b)(9)) consistent with the Court's opinion in State v. Byrd, 198 N.J.

319 (2009). The amendment proposal was presented and discussed at a Judicial

Conference on September 7, 2010 in accordance with the requirements of N.J.S.A.

2A:84A-34. The proposal, as recommended by the Supreme Court Committee on the

Rules of Evidence, was previously announced by public notices dated August 2, 2010

and August 20, 2010.

The Court's Order notes that the effective date of the amendments is July 1,

2011. The action of the Court is subject to the terms of N.J.S.A. 2A:84A-36.
