CIVIL CASE INFORMATION STATEMENT (CIVIL CIS) – REVISIONS TO SIDE 2 (EFFECTIVE OCTOBER 1, 2016)

The Civil Case Information Statement (“Civil CIS”) is included in the Rules of Court as Appendix XII-B1. The Supreme Court has previously delegated to the Administrative Director the authority to approve revisions to Side 2 of the Civil CIS. Accordingly, this notice promulgates the following revisions to Side 2 of the Civil CIS, effective October 1, 2016:

- The removal of case type 278 for litigation involving the drugs Zometa and Aredia pursuant to the Supreme Court’s April 12, 2016 Order;
- The removal of case type 279 for litigation involving Gadolinium based diagnostic agents pursuant to the Supreme Court’s April 12, 2016 Order; and
- The removal of case type 288 for litigation involving allegations of commercial bribery and other torts against Prudential Life Insurance Company of America pursuant to the Supreme Court’s April 12, 2016 Order.

The complete Civil CIS as revised effective October 1, 2016 is attached.
