

SUPREME COURT OF NEW JERSEY

In furtherance of implementation of Criminal Justice Reform, every vicinage will be establishing either a centralized first appearance process and location or a CJP (Centralized Judicial Processing) process and location, with some vicinages having previously already done so. Pursuant to Rules 3:4-2(b) and 7:3-1(b), as amended August 30, 2016 to be effective January 1, 2017, the CJP or centralized first appearance judges shall be designated by the Chief Justice. Accordingly, this omnibus order lists for each vicinage the CJP/centralized first appearance judges, specifically, those Municipal Court judges cross-assigned to all of the Municipal Courts in that vicinage for the specific purpose of conducting first appearances and setting conditions of pretrial release in that vicinage's CJP or centralized first appearance process. Any Superior Court judges designated under the rule will be by separate order. The designations set forth in this order shall be effective as of the date of the order or upon commencement of the vicinage's CJP or centralized first appearance process, whichever is later. The designations also will supersede any designations previously made in orders relating to individual vicinages.
