Leaving the Scene of an Accident Resulting in Death (3/13/17) Leaving the Scene of an Accident Resulting in Serious Bodily Injury (3/13/17)

These two charges were revised due to <u>State v. Sene</u>, 443 <u>N.J. Super</u>. 134, 140-41 (App. Div. 2015), <u>certif. denied</u>, 224 <u>N.J.</u> 282 (2016), in which the Court interpreted "involved in an accident" to mean that the driver's actions contributed to the accident and the person knows of the causal relationship between his/her actions and the accident. Additionally, pursuant to <u>State v. Fisher</u>, 395 <u>N.J. Super.</u> 533, 541 (App. Div. 2007), the fourth element provides that the defendant knowingly left the scene of that accident under circumstances that violated the provisions of the New Jersey Motor Vehicle Code [N.J.S.A. 39:4-129].

2C:12-1b(7)

Aggravated Assault – Significant Bodily Injury (6/12/17)

This charge was updated to conform with the format used for the two options for causing significant bodily injury and attempting to cause significant bodily injury in the new model charge for Aggravated Assault – Significant Bodily Injury to a Victim of Domestic Violence. An explanatory footnote was added that options one and two are not mutually exclusive and, that it may be appropriate to charge the jury as to both respective theories, causing and attempting to cause significant bodily injury, depending on the nature of the Indictment and the evidence adduced at trial.

Aggravated Assault – Significant Bodily Injury to a Victim of Domestic Violence (6/12/17)

Theft of Immovable Property (3/13/17)

This charge was revised to add the definitions of "interest" and "transfer of an interest in real estate" as defined in <u>State v. Kosch, Jr.,</u> 444 <u>N.J. Super.</u> 368 (App. Div.), <u>certif. denied</u>, 227 <u>N.J.</u> 369 (2016).
