CIVIL CASE INFORMATION STATEMENT (CIVIL CIS) – REVISIONS TO PAGE 2 REGARDING TRACK IV CASE TYPES (MULTICOUNTY LITIGATION)

The Civil Case Information Statement (“Civil CIS”) is included in the Rules of Court as Appendix XII-B1. The Supreme Court previously delegated to the Administrative Director the authority to approve revisions to Page 2. Accordingly, this notice promulgates the following revisions to Page 2 of the Civil CIS, effective immediately:

- The addition of case type 630 under Multicounty Litigation involving the Proceed® Surgical Mesh and Proceed® Ventral Patch hernia mesh products pursuant to the Supreme Court’s March 12, 2019 Order; and
- The removal of case type 287 involving oral contraceptives Yaz®, Yasmin®, and Ocella® pursuant to the Supreme Court’s January 29, 2019 Order terminating the MCL.

The complete Civil CIS as revised effective May 16, 2019 is attached.
