## MEDIA / PUBLIC- REVISED FORM - REQUEST FOR PERMISSION TO PHOTOGRAPH, ELECTRONICALLY RECORD OR BROADCAST A COURT PROCEEDING

The Judiciary has approved a new uniform form to be completed by members of the press or others requesting permission to photograph, electronically record, or broadcast a court proceeding. The new form replaces an earlier statewide form (CN 11862) that was promulgated by Directive #08-14 ("Supreme Court Guidelines on Electronic Devices in the Courtroom").

The updated form is posted on the Judiciary's public website (https://www.njcourts.gov/forms/11862\_perm\_photo\_rec\_brdcst\_sc.pdf) and is effective immediately. The form provides information about the specific equipment to be used by members of the media (or others seeking permission to record) as well as the intended use of the recordings. For example, the form provides information on whether the requestor is seeking to livestream a court event. It also details specific consequences for a violation of the agreement contained in the form.

A person seeking to photograph, electronically record, or broadcast a court proceeding must complete the form and submit it to the Trial Court Administrator or designee. The judge, TCA, or other designated court staff will indicate on the form whether the request is granted or denied.

The Supreme Court Guidelines on Electronic Devices in the Courtroom currently are under review. The attached new media request form will be incorporated in an updated version of the Guidelines, which should be promulgated soon.
