## NOTICE TO THE BAR

## ATTORNEYS REQUIRED TO PROVIDE AND MAINTAIN A CURRENT CELL PHONE NUMBER (AND EMAIL ADDRESS) AS PART OF ANNUAL ELECTRONIC REGISTRATION

By Order of July 20, 2017 (previously published), the Supreme Court relaxed Rules 1:20 and 1:21 so as to require New Jersey attorneys to provide an email address as part of the annual electronic registration process and to maintain a valid email address to be used for official Judiciary purposes.

The Court by Order of July 29, 2019 (published with this notice) added the requirement that attorneys also provide and maintain a current cell phone number to be used for official Judiciary purposes. The additional requirement of a cell phone number will allow for the implementation of a more secure two-factor authentication process. That process will support an added security protection that is the industry standard to confirm that the individual accessing the Attorney Registration and Payment system is authorized to do so.

Attorneys will be required to update any changes to their email address or cell phone number within 30 days of that change. An attorney may request an exemption (as to the requirement to provide an email address and/or a cell phone number) by sending that request in writing to Hon. Glenn A. Grant, Acting Administrative Director of the Courts, through the Superior Court Clerk's Office, P.O. Box 971, Trenton, New Jersey 08625; any such submission must detail the basis for the request.

The Attorney Registration and Payment System currently includes fields for attorneys to provide both an email address and a cell phone number. Attorneys are encouraged to include that information now. The Court's order provides that the two fields for an attorney's individual email address and cell phone number will become mandatory no later than January 1, 2020, to coincide with the next annual electronic registration process. At that time, attorneys will not be able to complete the registration process without providing both an email address and a cell phone number.

As of the date of this order, the Attorney Registration and Payment System includes

fields for attorneys to provide an email address and a cell phone number. Fields for an attorney's

individual email address and cell phone number will become mandatory no later than January 1,

2020 in order to implement the terms of this order. This order and the July 20, 2017 order will

remain in effect pending development and adoption of conforming rule amendments.
