

## NOTICE TO THE BAR

### NEW JERSEY ATTORNEY ELECTRONIC REGISTRATION AND PAYMENT REQUIREMENTS AND UPDATES; NO-COST CLE TRAINING

This is a reminder that New Jersey attorneys each year must complete their annual registration and payment electronically through the Judiciary's web-based application at <https://www.njcourts.gov/attorneys/attorney-registration>. The 2025 electronic registration form will be available in January 2025.

New Jersey attorneys are required annually to file a registration statement in a form prescribed by the Administrative Director of the Courts with approval of the Supreme Court and to pay an assessment in an amount determined by the Supreme Court. All attorneys must complete their annual attorney registration and pay the required annual fee electronically, except those attorneys who qualify for one of the limited exceptions approved by the Supreme Court.

The Judiciary, through the Superior Court Clerk's Office, is offering a number of free training sessions between October 2024 and January 2025 for attorneys on the updated attorney registration application, including ethical requirements and reminders, electronic filing requirements, eCourts notifications, employer association and changes, internet security considerations, and common troubleshooting tips related to the attorney registration process. The sessions will be conducted using Microsoft Teams. Attorneys must register in advance.
