## Vicinages to Conduct Virtual Court Election Day Hearings

Superior Court judges will be available to conduct remote hearings for any election challenges or issues in New Jersey on Tuesday, May 12.

This year's election was moved from April 21 because of the COVID-19 pandemic. Under the new arrangement, Tuesday's election will only be vote by mail. The county clerk's offices have mailed ballots to all registered voters.

If appropriate, matters will be promptly heard by a designated judge with notice to the election officials. Election officials, petitioners, and attorneys will be able to appear before the designated judge by video or telephone.

In Bergen County, elections are in Cliffside Park, Fairview, Garfield, Hackensack, Oakland, Ridgewood, Ridgefield Park and Teaneck.
